

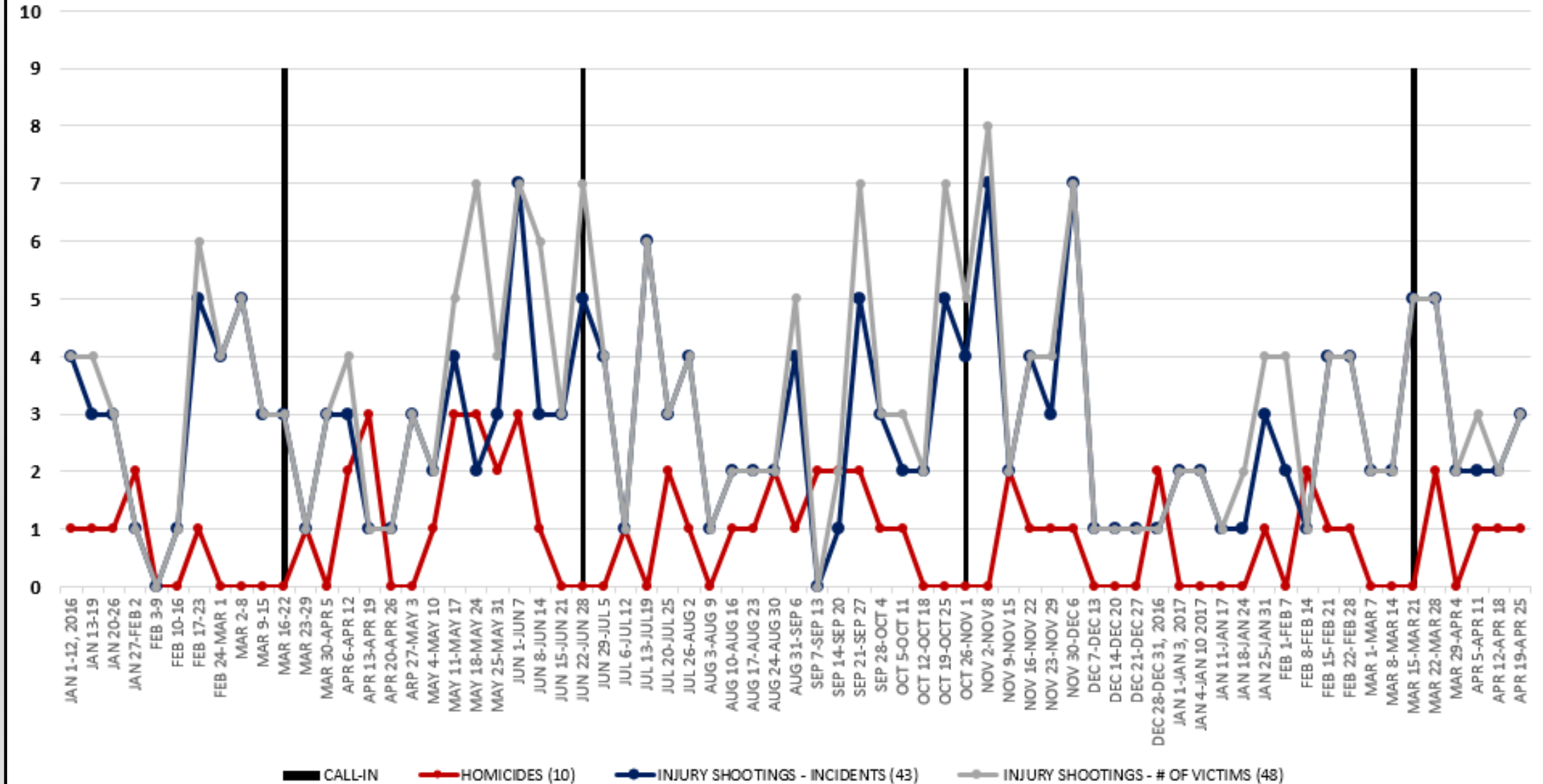

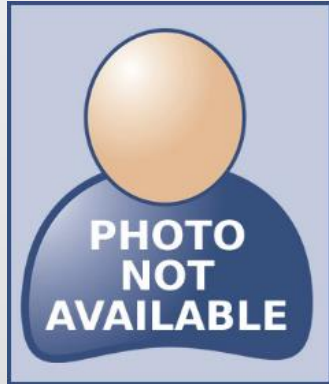

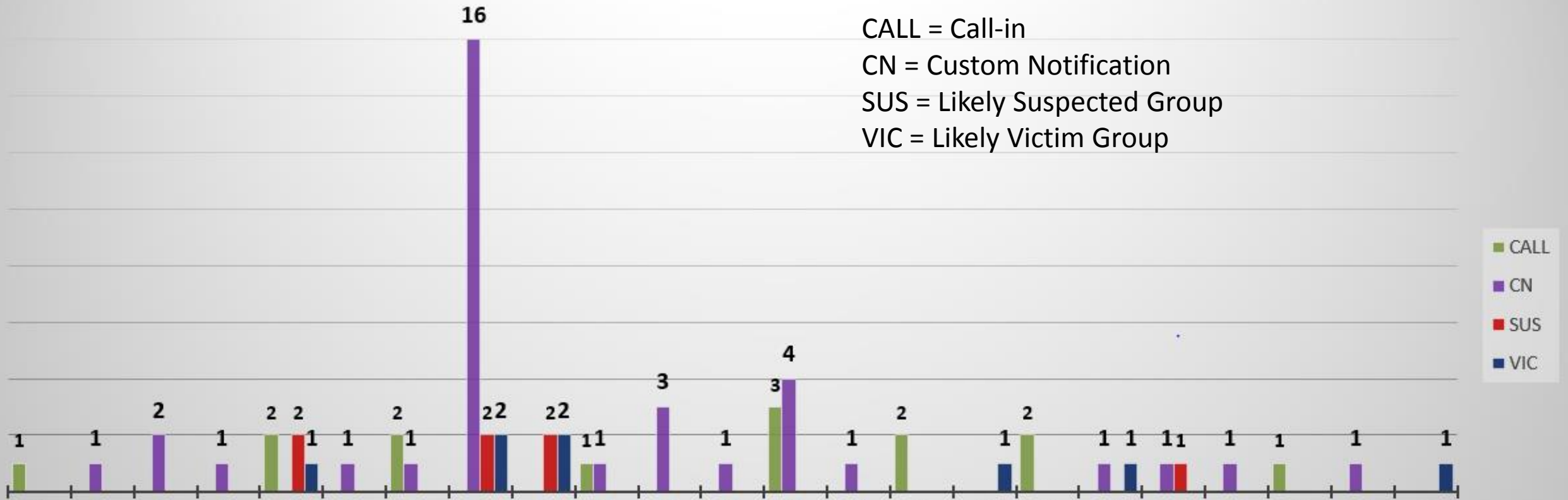

YTD Shooting Scorecard

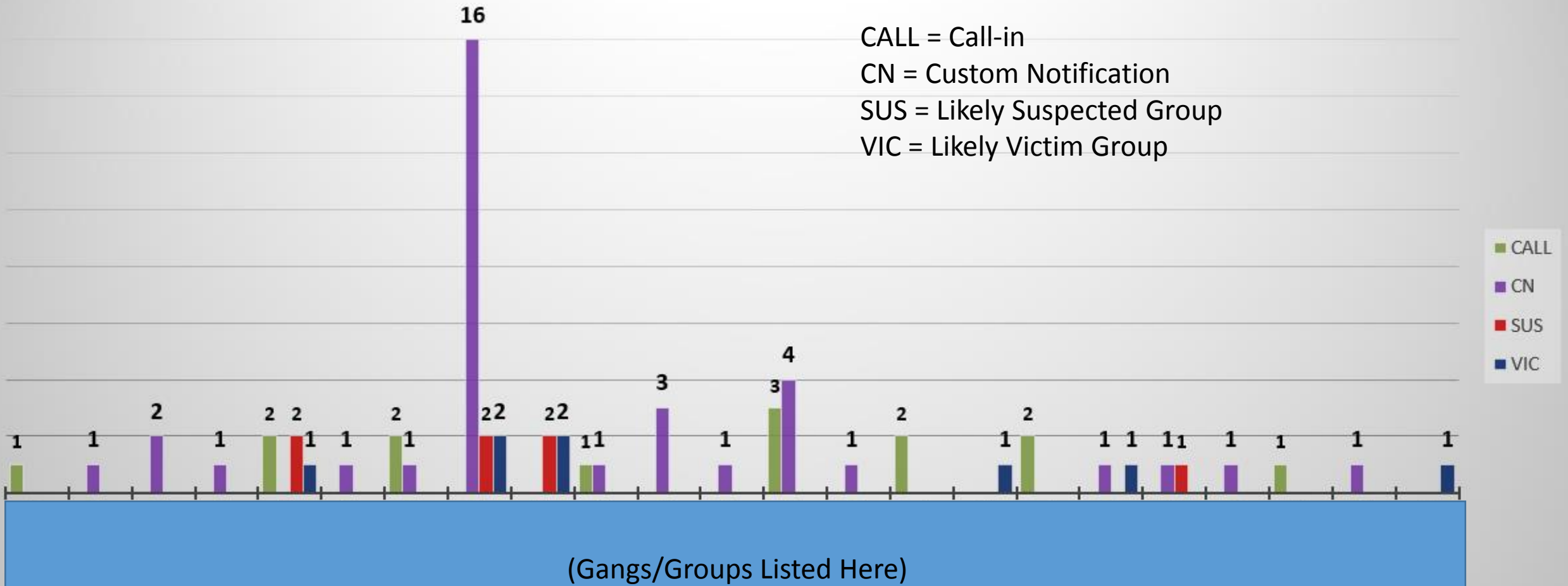

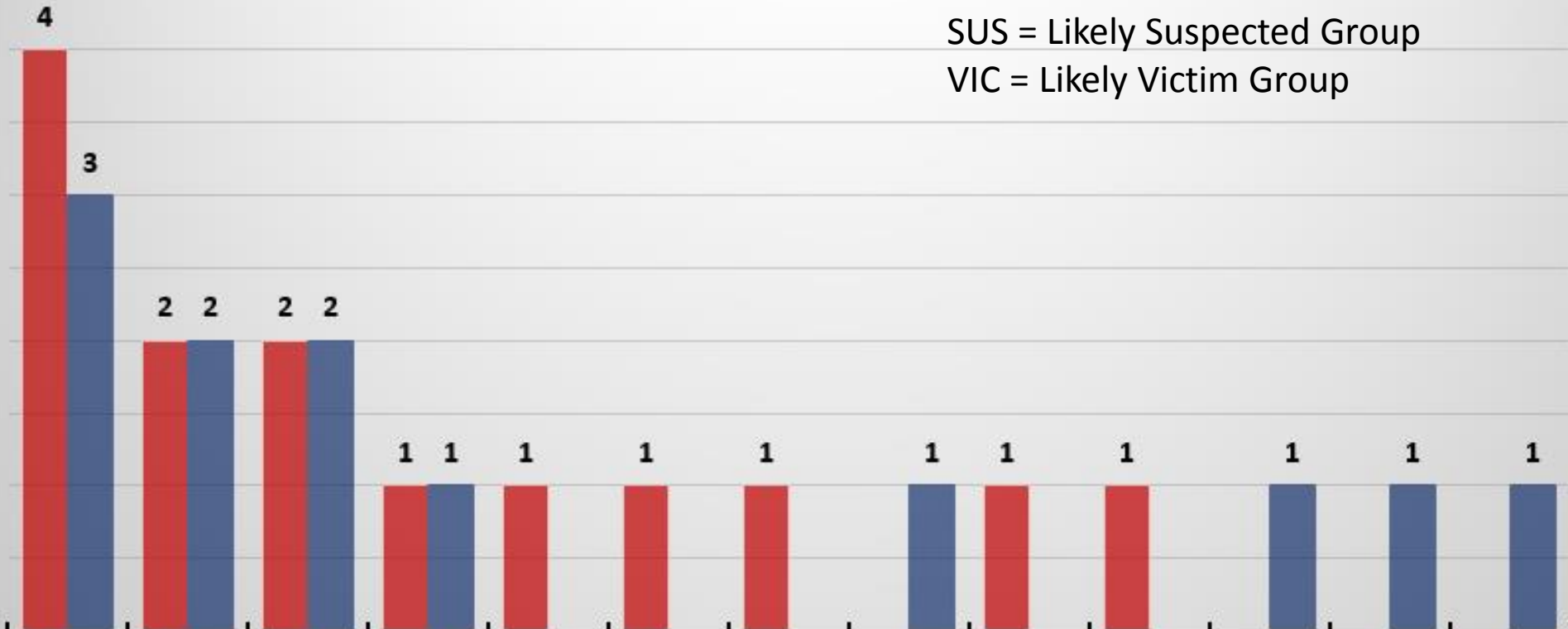
Shooting Scorecard - Three Months

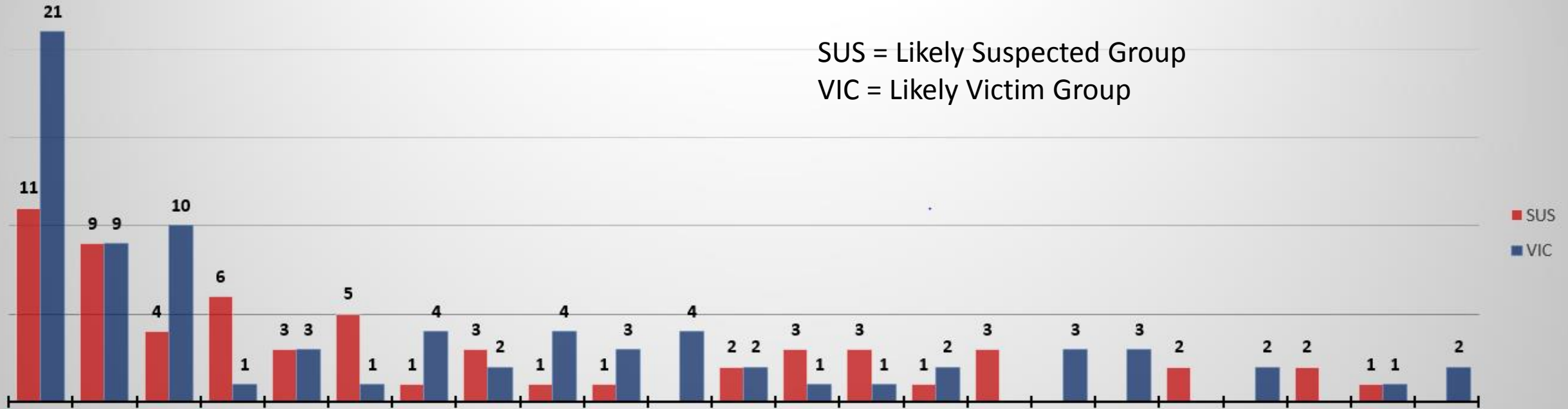
