




Rate of Violent and Non-Violent Reported Crimes, 1980-2014





16-17 year-olds





Enforcement Rates for Males by Race/Ethnicity for New York City from 2003 to 2014


21-24 year-olds


Enforcement Rates for Males by Race/Ethnicity for New York City from 2003 to 2014 35 years and older




Summons Outcomes: 2003-2013


Summons Outcomes: Defective and Legally Insufficient 2003-2013


Summons Outcomes: Dispositions 2003-2013
